

1 The Parties

1.1 The Company “Eventbox Asia” Eventbox Asia (henceforth will be known as “Merchant”) is a Platform for Event Hosting, Registration and Ticketing. We aim to provide an all-around event experience through our event hosting platform and guided event mobile apps through our services.

1.2 The Registered Party “Users”

All users who register with the website and platform submit to the knowledge and agreement that the Personal Data collected is for the purpose of registration, ticketing and personalize website features. All transactions are processed through a gateway provider (Mobile88 Sdn Bhd) and Personal Data is only accessible by a limited number of persons under Merchant company and are required to keep the information confidential. In addition, all sensitive/credit information supplied to us under this website is encrypted via Secure Socket Technology. All transaction data is stored on our payment merchant servers (Mobile88 Sdn Bhd) and not on our servers. Non-Malaysian participants must ensure that they obtain all necessary entry, exit and other documents. Please contact the applicable Consulate or Embassy for these additional requirements.

1.2.1 Registration Terms & Conditions

All users acknowledge that all the information they've submitted for registration purposes is complete and accurate. By submitting the information, you have sent acknowledgement that you have authority to register and/or act as an agent to complete the registration of Events on behalf of yourself and/or party(s) you are registering (Registered Parties) through our platform. Your acts for and on behalf of the Registered Parties shall be binding upon them as if they have completed it themselves.

1.2.2 Registration Payments

All users also warrant and have the full authority to use the debit/credit card or online bank transfer for all transactions made in this platform. You also hereby indemnify Eventbox Asia of any and all claims loss damage related to the credit card and debit card transactions done over Eventbox Asia portal. The confirmation of participation is VALID only once registration fees is successfully made. Any delays to the confirmation email, please forward your enquiry and payment information to info@eventboxasia.com. A confirmation email will be sent out once payment made is successful. The confirmation email will be used as proof of confirmed registration and used to redeem tickets at Event. With the confirmation of payment, all users send acknowledgement and agreement to abide by the terms and conditions as declared by the Organizer in their respective Event Pages. All transactions through Eventbox Asia will be in Ringgit Malaysia. For international participants paying in foreign currency or using foreign banking, currency conversion will be applied into Ringgit Malaysia. Currency Conversion should be done with your local banks, before making payment.

1.2.3 Google Analytics

GoEvents uses Google Analytics to only record Demographic & Interests Tracking, but does not employ Google AdWords. Users have the option to turn off Tracking using the Settings within the Browser.

1.3 The Event Hosts “Organizers”

Organizers are subject to applicable legislation and where such legislation does not exist or apply with such prescribed regulations or industry prescribed respecting holdback percentages hereby acknowledge and give authorisation to Merchant to collect payment on behalf of Organizer. The Organizer reserves the right to change the event date or venue at their own discretion, and will be announced at their respective pages.

1.3.1 Event Management Administration Fee

There will be an administration fee of RM 500.00 for each event.

1.3.2 Event Cancellations

Should there be an event cancellation by the Organizer, there will be a cancellation fee of RM 2500.00. In the event that there is an event cancellation, any enquiries or refund enquiries will be directed solely to the Event Organizer.

2 Personal Data Protection Act 2010

1. By providing any information, personal or otherwise of yourself or other person who you are registering for, in order to sign up for the Event or any activity(ies) involving the Organizer and the Event Sponsors (if any), you and /or any other person who you are registering for are deemed to have agreed to the following:

2. The Personal Data of the Registered Parties shall be used by the Organizer and authorised Contractors for the purposes of sending communication materials to the Registered Parties, including but not limited to, direct mailers, emails, Short Messaging Service and/or telephone calls.

3. The Organizer may engage the services of third parties (Contractors) to process the Registered Parties' Personal Data. All such third parties are contractually obliged not to use the Registered Parties' Personal Data for any other purpose, other than as specified herein.

4. Any of the Registered Parties has the right, at any time, to:

- withdraw his/her consent for the use of the Personal Data;
- to request for any correction/update of the Personal Data; or
- raise any general queries regarding the use of his/her Personal Data;

We may also release information when it's release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property or safety.

3.1 Third-party links We do not include or offer third-party products or services on our website.

3.2 Cookies

We do not use cookies for tracking purposes You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies.
